4. Covid19 – Travel Advisory

REQUIREMENTS FOR ENTRY INTO THE REPUBLIC OF SERBIA

To prevent import of infectious disease onto the territory of the Republic of Serbia, as of 20 December 2020, individuals coming to the Republic of Serbia, shall be allowed to enter the Republic of Serbia solely provided they have a negative RT-PCR test to the virus SARS-CoV-2, not older than 48 hours, issued by a referential laboratory of the country they are coming from, that is the country they are entering the Republic of Serbia. Individuals coming from the USA instead of a negative RT-PCR test are recognized, under the same conditions, a negative Antigen FIA Rapid test. Should there be a delay when entering the Republic of Serbia that cannot be attributed to the passenger but to an existence of an extraordinary occurrence that could not have been foreseen, avoided or discarded (delay/postponement of flight, bus or train departure, or similar event), then the test cannot be older than 72 hours when entering the Republic of Serbia.

PCR Test for traveling back to your country can be organized on 12. or 13. January at 08h at Public Health Center in Novi Pazar (30km from Ski Resort Kopaonik). PCR results will be sent to your e-mail, next day. Price is 18.000,00 RSD (around 160 EUR).

All competitors must wear bibs during all competition and award ceremonies.

8. Accident Insurance

Each competitor must have his/her own medical insurance. The Organizing Committee sponsors, suppliers, Snowpark Kopaonik, the FIS and the Serbian Ski Association decline any responsibility for accidents, damaged or lost equipment and second and third party claims during the event.

9. Liability

All athletes, officials and members of the National Association who attend and participate in the event shall do so at their own risk. The Organizing Committee, Snowpark Kopaonik, the Serbian Ski Association, sponsors and suppliers, employees and volunteers shall not be responsible for any losses or injuries incurred or suffered by any athlete, official or other person in conjunction with the organizing or staging of the event.

Only for competition days an event fee of €20 per competitor is charged, to be paid at the race- office, on the day prior to the event the latest. Lift tickets included for competition days.








<p>Hygiene measures and code of conduct</p>	<div style="display: flex; justify-content: space-around; align-items: flex-start;"> <div style="text-align: center;">  <p>Keep your distance</p> </div> <div style="text-align: center;">  <p>Wear a face mask</p> </div> <div style="text-align: center;">  <p>Cough and sneeze into a tissue or your elbow</p> </div> <div style="text-align: center;">  <p>Wash your hands thoroughly</p> </div> <div style="text-align: center;">  <p>Avoid shaking hands</p> </div> <div style="text-align: center;">  <p>Record contact data</p> </div> <div style="text-align: center;">  <p>If you have any symptoms, get tested and stay at home</p> </div> </div> <p>Masks must be worn if it is not always possible to comply with social distancing rules. Close contact is defined as contact that lasts longer than 15 minutes or repeatedly falls below a distance of 1.5 meters without protective measures.</p>

<p>Prevention</p>	<ul style="list-style-type: none"> · Health takes the highest priority; a high level of solidarity and individual responsibility is required. · Persons with COVID-19 symptoms must refrain from attending the event. · The OC and Serbia Ski must be informed as soon as possible if COVID-19 is diagnosed after the event (within 14 days).
<p>Arrival and departure</p>	<ul style="list-style-type: none"> · Individually by private car/the team's own bus · The wearing of masks is recommended if arriving on a team bus (distancing rule). · FOPH rules must be complied with if arriving by public transport.
<p>Accreditation/team captain information</p>	<ul style="list-style-type: none"> · It is mandatory to wear a mask at Team Captains Meetings (TCM). The OC will provide disinfectant and waste bins with lids · Each team is responsible for ensuring that the information is circulated within their team and for compliance with the protection regulations. · Visitors have no access to the competition area
<p>Accommodation</p>	<ul style="list-style-type: none"> · In accordance with FOPH guidelines for the hotel industry.
<p>Food/meal times</p>	<ul style="list-style-type: none"> · In accordance with FOPH guidelines for the hotel industry and the respective catering provider/institution.
<p>Conduct at the competition site</p>	<ul style="list-style-type: none"> · Registered team members can access the competition grounds subject to compliance with the applicable codes of conduct and protective measures. Access control in consultation with the OC. · Social distancing rules must be observed at the start area, at course inspection and at the finish area. Start line judges must wear masks.
<p>Start numbers</p>	<ul style="list-style-type: none"> · Start numbers are deposited at start number stands and must be personally collected and returned.
<p>Award ceremony</p>	<ul style="list-style-type: none"> · Masks must be worn during the award ceremony.
<p>Communication</p>	<ul style="list-style-type: none"> · All registered teams will be contacted by the OC at their registered address and sent the program and protection concept.
<p>Protective equipment</p>	<ul style="list-style-type: none"> · All participants and visitors are responsible for their own protective equipment (masks, disinfectants) and will bring these with them themselves.
<p>Contact tracing</p>	<ul style="list-style-type: none"> · The list with contact details of team captains must be stored until 14 days after the event and must be identifiable at the request of the cantonal health authorities.
